Ben Rauschenbach updated Council on the status of Walter O. Bigby Carriageway Phase 1 and Phase 2. He noted that Phase 1 was about 90 percent complete.

Mr. Montgomery recognized Pam Glorioso and Stacie Fernandez for their dedication and going above and beyond to help the City Finances by applying for additional CARES Act Funding.

There being no further business to come before this Council, the meeting adjourned at 3:34 PM by Mr. Montgomery, Jr.
